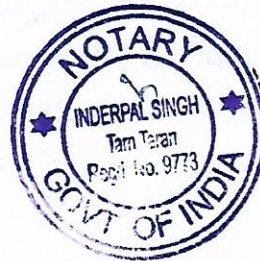




Sir/Madam,

The above said Recognition is based on the following conditions.

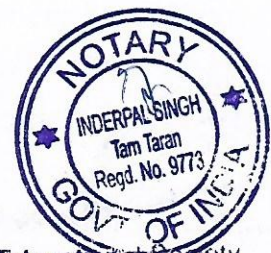
- 1 The Recognition is not for extension. It is no meaning that is compulsory for Recognition/relating to Eighth Class..

- 4 The School will compensate as per para No. 3 of the school for children under Art 12 of Sub-Section 2 and will maintain the separate bank account for such compensation.
 - 5 Institution/School will not get the Capitation Fee and will not apply any election for the Parents or Surplus of the Children.
 - 6 The School will not refuse to admit the child for having No Birth Certificate and will abide by the Art 15 of the Act . School will make it sure that
 - a) No Admitted child will return to class or will out from the school until his basic education does not complete.
 - b) No Physical Punishment or Mental harassment will be given to the Child.
 - c) No any child have to pass the Board 's Examintion after completing the basis education.
 - d) It is compulsory for Teachers that they should complete the Minimum Educational Qualifications under Art 23 (1).But It is condition that if the present teachers does not complete the minimum qualification and they will complete it within the period of 5(five) Years.
 - e) Teachers will complete their responsibilities under Art 24 (1) of the Act.
 - f) Teacher will not busy himself in the Private Tuitions.
 - 7 The school will following the Syllabus fixed by the Higher Authority on the basis of subject.
 - 8 The School,will abide by the Terms and conditions of the Art 19 of the Act. Following are the facilities provided in previous reports 'as under:-
 - 1 The Covered Area of the School should be 15000 Sq Fts and Uncovered should be 12000 Sq fts.

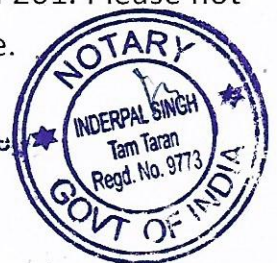

- 14 The Recognition Code No. of Your School is R.T.E./T.T. 261. Please not it and enter the same for correspondence with this office.

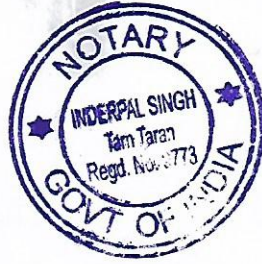
